Would you support Medicaid expansion to cover all gender-affirming care for transgender people, including trans youth and adolescents?

YES

Transgender people face disproportionate levels of discrimination when incarcerated. Do you support efforts to prohibit discrimination of transgender people when incarcerated, including housing them in the unit appropriate to their specified gender?

YES - I was also the FIRST candidate in the state of Maryland to release a LGBTQ+ Rights policy agenda back in January 2021 (<https://jainforgov.medium.com/lgbtq-rights-46d6d41ffb8f>). My plans include protecting reproductive justice (including access to gender affirming hormone replacement therapy); investing more in mental health professionals; prohibiting housing discrimination based on sexual orientation; reducing food insecurity; comprehensive sex ed in public schools (that teaches about everything from abstinence to contraceptives, to LGBTQ inclusion, sexual orientation, gender identity and reproductive rights); prevent discrimination that occurs during jury selection; and access to full employment.

Do you believe in the bodily autonomy of all Marylanders, including transgender peoples' right to medical autonomy, and the rights of pregnant transgender people?

YES - it's all part of having true Reproductive Justice. Furthermore, I was the first statewide candidate in Maryland to release a Reproductive Justice platform back in January 2021 (<https://jainforgov.medium.com/womens-rights-8e101a44e405>) - which includes the need to —

- (1) Enshrine essential healthcare services (like abortion care, contraceptive coverage and gender affirmation treatment) in our State Constitution;**
- (2) Require all public schools to have comprehensive sex-ed in health classes. Students must learn about everything from abstinence to contraceptives, to period poverty, to domestic violence, to LGBTQ inclusion, gender identity and reproductive rights;**
- (3) Require all public schools to provide free menstrual products in bathrooms. If toilet paper can be free for all students, so should menstrual products;**
- (4) Expand availability of medication abortion and ensure that pharmacists (who are the most accessible and affordable provider for residents in low-income and rural communities) keep stocks of mifepristone (one of two drugs used for medication abortion) on hand, and can dispense the medication with a prescription; and**
- (5) Expand lactation accommodations and ensure employers provide lactation accommodation for new mothers..**

Yes. As Governor I will pass the Trans Health Equity Act. I believe health care is a human right, and that includes gender-affirming care. I will also make undocumented Marylanders eligible for Medicaid and the state health insurance exchange so that no one is denied trans health care because of their immigration status.

Yes. As Governor I will pass the Transgender Respect, Agency and Dignity Act, requiring incarcerated people be housed in facilities matching their gender identity and mandating staff consider the health and safety of transgender, nonbinary and intersex inmates.

Yes. Burdensome requirements place a cost on transgender Marylanders and only serve as another barrier to care and social services. Current forms offered by the Department of Health to change gender on a birth certificate asks for sign off from a licensed health care provider or proof of a court order, which add additional costs and needlessly delay the process.

Do you believe in the bodily autonomy of all Marylanders, including transgender peoples' right to medical autonomy, and the rights of pregnant transgender people?

Yes. The overturning of Roe v. Wade not only affected abortion care, but will have widespread ramifications for transgender health care as well. We must protect the ability of people to make their own health care decisions, including around gender-affirming care. We also need to make sure our approach to abortion care, including the training of providers, is inclusive. Pregnant trans and nonbinary people face even more barriers to abortion access and discrimination from health care providers. On top of abortion rights, we need to protect all aspects of bodily autonomy in Maryland, including repealing the anti-sodomy law that still exists in this state today.

Would you support protections for transgender people seeking refuge in Maryland when leaving other states that have passed prohibitions on healthcare or other similar policies? Additionally, will you support measures to increase Maryland's capacity to provide trans-specific services, including providing funding to hire qualified trainers to train new service providers?

Yes. We will make Maryland a sanctuary state for trans individuals seeking care and we will refuse to cooperate with law enforcement in states who are criminalizing trans health care and attempting to investigate trans people. Similar to the Abortion Care Access Act, which will provide funding for training abortion providers, I will support legislation that funds training for trans-specific health care services along with training all health care providers to be culturally competent around serving trans patients. I also support repealing Maryland's laws that essentially criminalize HIV, which stem from discrimination against LGBTQ+ people and are yet another way people are deterred from seeking care.

We've been sold the line that we can't use this program to protect these individuals because it comes down to dollars and cents. Expanding Medicaid for the transgender community is not going to break the bank. I'm in full support of expansion. First, I would use the influence of my federal office to speed the passage of SB682/HB746 in the Maryland legislature. Second, Medicaid is meant to provide healthcare to low-income individuals. Third, less than 1 percent of Americans identify as transgender in America according to the CDC.

Transgender people face disproportionate levels of discrimination when incarcerated. Do you support efforts to prohibit discrimination of transgender people when incarcerated, including housing them in the unit appropriate to their specified gender?

My plan is to create non-profit State prisons. This does multiple things to reform our current for-profit system, but fixing discrimination is one major area. In a non-profit prison system success is measured by drops in recidivism. This is achieved by reforming the system and allowing intensive rehab and reintegration procedures to be adopted within prison walls. Ensuring the safety and mental well-being of all incarcerated individuals is necessary to achieving these goals. This includes safe housing of transgender people and other measures built to prohibit discrimination against them.

Do you support transgender Marylanders' ability to self-identify their gender marker when requesting a change on legal identity documents (such as birth and death certificates)?

I would use the influence of my federal office to speed the passage of HB 370 in the Maryland legislature. Like California a person should have the legal right to self-identify in all cases. I also recognize that this is not a fix all. Work still needs to be done to ensure fair and equitable inclusion of transgender individuals into all facets of American life.
